Department of History (HIST)

Major in History (B.A. or B.S.)

Requirements in Department (40)

Students must successfully complete HIST 395, and at least one 400-level NIU history course (excluding HIST 400 and HIST 496) before taking HIST 495. At least two such 400-level NIU history courses (excluding HIST 400, and HIST 495, and HIST 496) are required to complete the major.

Rationale: Currently HIST 496 does count as one of the 7 upper-division content courses required for a major in history, but it is not counted toward meeting the requirement for 400 level courses. This exclusion is a relic from earlier catalogs that did not include HIST 496 as a content course that met major requirements. Similar methods courses, particularly HIST 492: Introduction to Public History and HIST 494: Oral History are allowed to fulfill the 400-level course requirement. HIST 496 involves considerable disciplinary content and disciplinary skill development easily equivalent to other 400-level courses in the department. When the History Department revised the numbering of HIST 270 and HIST 271 to HIST 364 and HIST 365, it assumed erroneously that these courses would be removed as options in our lower division requirements. We request that HIST 364 and HIST 365 be eliminated from what the department has long understood as lower division requirements because HIST 364 and HIST 365 are now upper division courses. (The department recognizes that the catalog language did not indicate that this requirement was one at the lower division). We are moving the location of HIST 260 and HIST 261 for clarity's sake because students no longer choose them from a list. Deletion of HIST 478 and HIST 479.
